Official Terms and Conditions:

March 21, 2009

Beginning March 21, 2009 through October 20, 2009, Warrior Boats will award cash prizes to the **original registered Warrior Boat owner**, fishing and winning (in their Warrior Boat) 1st, 2nd, or 3rd place in a sanctioned fishing tournament. All sanctioned events must have a **minimum of 75 boats** to qualify, and include only those tournaments specified by Warrior Boats. For tournaments that have multiple winning divisions, Warrior High Achiever's Cash will only be awarded to the overall tournament winner.

The full amount of the cash prize will be awarded to the original registered Warrior boat owner if your boat is year 2008 and newer. If you are an original registered Warrior boat owner with model year 2007 and older, you will receive 1/4 of the cash award. The Published Official Standings of each tournament will determine the winner. In the event of a dispute, Warrior will not be obligated to pay until the dispute has been settled and officially announced. Rule determinations will be final.

Warrior Boats must receive your registration 14 days prior to a tournament start date. Registrations received less than 14 days prior to a tournament start date will be considered null and void. Registration forms can be obtained by going to www.warrior-boats.com, or by contacting the Warrior factory. Winning claims must be submitted to Warrior Boats within 30 days of the tournament and must include proof of win including the complete tournament standings, proof of ownership and winner's Social Security number. Winning claims not received within 30 days of the tournament will be considered null and void. All cash award recipients will receive a 1099. Claims will be audited. As a Warrior owner, there is no limit to how many tournaments you can win.

Warrior is not responsible for payout if registrations are not received 14 days prior to tournament start date; for registrations not received by Warrior Boats; for tournaments that have less than 75 boats; or for winning claims not received within 30 days. Registrations must be mailed, emailed or faxed and must include this completed form. Incomplete forms will be rejected. Verbal registrations will not be accepted. At any time, Warrior Boats may change, alter or discontinue this Award Program at its own discretion.
